PROGRAM DESCRIPTION

This program is designed to assist attorneys who volunteer their time at brief advice clinics sponsored by The Legal Aid Society of Columbus and the Columbus Bar Association. Our 2013 training will be divided into two sessions:

Part 1 (May 30th) Attorneys will receive instruction on issues unique to low-income clients and tips on how to best meet the needs of clients in a clinic setting. We will provide basic issue spotting and information about the array of public assistance programs available to low-income individuals. The training will also focus on serving clients with disabilities and the legal issues impacting low-income consumers.

Part 2 (June 12th) Attorneys will receive basic instruction on domestic legal issues facing low-income families, landlord-tenant law basics, and record sealing requirements and procedures.

Dianna Parker has been a staff attorney at LASC since 2007. A 2005 graduate of The Ohio State University Moritz College of Law, Dianna has practiced in the areas of education and housing law and is now the Pro Bono Coordinator.

Jamie Shier is a 2005 graduate of The Ohio State University Moritz College of Law. She joined LASC in 2006, originally practicing with the Child and Youth Law Program. Since that time, Jamie transitioned into the Public Benefits unit, where she advocates for low-income individuals and families in the areas of SSI, Ohio Works First, and Medicaid.

Kerstin Sjoberg-Witt is the legal director for Disability Rights Ohio (formerly Ohio Legal Rights Service). Prior to January 2009, Sjoberg-Witt was an associate in the Trial Practice Group at Jones Day, where she represented business and other organizational clients in civil issues. She also participated in pro bono matters, including a fair housing action that resulted in a jury verdict of \$10.8 million for a group of residents outside Zanesville.

Dorian Baum is owner and sole practicing attorney for Baum Law Office in Lancaster, Ohio. A 2009 graduate of the University of Akron School of Law, Dorian handles cases in criminal defense, divorce/dissolution, child custody, civil litigation, collections, landlord-tenant, commercial leases, and oil & gas law.
