In return for **21 CLE credits and 10 pro bono CLE credits**, participants are required to complete a **60 hour pro bono practicum** assisting litigants in NYC Family, Civil, Housing and Supreme Courts within 6 months of training. (Newly admitted attorneys may use pro bono service credits on a carry-over basis.) Service in this program fulfills the pro bono requirement for NY bar admission. Experienced attorneys are also welcome to participate in this program.
