In the past two years, our Bench has seen a significant increase in the need for "family matters" legal services in Baltimore County. We believe this increase is attributable, in part, to changing demographics and staff reductions at Legal Aid. We have been advised that there is a critical shortage of volunteer lawyers by Maryland Volunteer Lawyers Service and that the need for attorneys to handle divorce and contested custody proceedings for indigent parents is acute.

Dear Counsel:

The Judges of the U.S. Bankruptcy Court for the District of Maryland are asking for your help to address a serious problem confronting our court.

Over the past two years, we have witnessed a significant increase in the number of cases filed in proper person, especially in Chapter 7. Because pro se debtors often do not understand the technical requirements involved, these cases not only clog the system but result in the denial of justice to otherwise deserving people.

The Maryland Volunteer Lawyers Service (MVLS), the state's largest pro bono program, provides free representation to such clients by matching them with volunteer attorneys, offering malpractice insurance, training, mentoring and the use of LEXIS at no charge. However, MVLS has advised us that it is no longer able to handle the volume of income-eligible clients who contact the service for help in filing Chapter 7 bankruptcy cases.

As a member of the bar of the U.S. District Court for the District of Maryland, you have indicated a willingness to accept a pro bono bankruptcy case. Accordingly, we have provided your name to MVLS. When you are contacted by a representative of MVLS and asked to represent a client, we are counting on you to respond affirmatively to the request.

By such response, you will not only be fulfilling your pro bono commitment, but more importantly, you will help to fulfill the promise of equal justice for all to those in the most unfortunate of economic circumstances.
