Low-income clients often have little resources or time to devote to end-of-life planning and therefore they frequently resort to "no planning" or improvised planning. This program will teach you appropriate planning techniques for medical, financial and personal issues that will benefit low-income clients and will also provide an understanding of the medical framework in which medical advance planning operates. The seasoned **faculty**, including legal services attorneys and a medical provider, will share their wealth of experience dealing with end-of-life issues so that you can competently volunteer to help low-income clients prepare a plan for the future. We encourage you to attend this program and then volunteer with your local legal services provider!

What You Will Learn

- How to interview and prepare a plan for the low-income client
- How to prepare and advise on Advance Health Care Directives, Powers of Attorney, Wills and other end-of-life planning techniques
- The medical view of advance planning for end-of-life, including the differences between palliative and hospice care and the intersection of the two approaches

Attorneys assisting pro bono clients with end-of-life planning matters through representation or in a variety of clinical settings, including medical-legal partnerships, senior services collaboratives, family-focused legal services opportunities, and other pro bono programs.
