COURSE DESCRIPTION

The Shriver Center's Affirmative Litigation training is a truly immersive introduction to the practice of seeking broad-based institutional reform through complex affirmative litigation. Substantive lectures and exercises on fundamental affirmative litigation justiciability issues are coupled with practice opportunities on emergency injunctive relief, surviving a motion to dismiss, and engaging in complex class-based discovery.

Affirmative Litigation training is delivered in two parts: online and in-person. Over the course of the three online weeks of the training, participants plan litigation and then draft a federal complaint to initiate. This work is supported by video lectures on practice issues like sovereign immunity, exhaustion, preclusion, and standing and mootness that participants review on their own time. After the complaint is drafted, participants come together for the in-person training, where they complete a host of interactive practice exercises associated with the case.

Between small group practice and strategy sessions, participants learn the practical nuts and bolts of

litigating in the state or federal courts, from e-filing to case cover sheets. Explicit attention is paid to the special needs of Legal Services Corporation-funded advocates and to alternatives to class action litigation. Participants leave with a clear understanding of the importance of impact-oriented affirmative litigation to the pursuit of equal justice for low-income clients.



Who Should Enroll?

Advocates seeking to expand their practice to include effective impact advocacy designed to make fundamental changes for their clients.

Typically, these attorneys will have some previous litigation experience.
